

DESCRIPTION:

This program assists in the development of new purposely-built rental housing, and provides the applicant with a municipal/ provincial grant of up to \$10,000 for each eligible new rental unit constructed.

ELIGIBILITY:

- Purposely-built new rental unit construction and non-residential property conversion to rental units are eligible.
- Buildings/ projects that are receiving funding under other provincial government housing development programs (except for Capital Rent Subsidy) and other City initiatives are not eligible for this funding.
- Rental Units must be in a multi-unit development (minimum 4 units).
- The applicant must enter into an agreement with the City of Humboldt respecting provision of the grant.
- Funding subject to Saskatchewan Housing Corporation ("SHC") approval of application.

GRANT DETAILS:

- The Rental Construction Incentive is funded by the City of Humboldt in partnership with the SHC. SHC will provide a \$5,000 grant per door. The City will match the grant with \$5,000.
- If the grant recipient(s) defaults under the program in any way for a minimum 5 years, a pro-rata repayment of the grant is required
- Conversion of the eligible rental units to ownership status (e.g. condos) or failure to rent out said condo during the initial five years in operation will result in a pro-rated return of the grant.
- The grant recipient(s) must keep the title to the property in their name(s)
- The applicant must pay the property taxes in full (100%) each year (property taxes become effective the date of possession).
- The applicant must comply with all of the terms and conditions of the Program.
- A total number of fifteen (15) units per year will be funded under this program on a first come first served basis.
- The City of Humboldt will register its interest on the property at its own expense.
- The signed agreement will be registered against the title of said property.
