CITY OF HUMBOLDT

BYLAW NO. 03/2002

A BYLAW OF THE CITY OF HUMBOLDT TO PROVIDE FOR THE LICENSING, REGULATING AND GOVERNING OF PERSONS ENGAGED IN CERTAIN OCCUPATIONS AND OF PLACES USED FOR CERTAIN PURPOSES

The Council of the City of Humboldt in the Province of Saskatchewan as follows:

- 1. This Bylaw may be cited as the Licensing Bylaw.
- 2. In this Bylaw, unless otherwise provided, all words and expressions used herein shall have the same meaning given them in *The Urban Municipality Act, 1984*, and relate only to the City of Humboldt.
- 3. In this Bylaw:
 - a) "Contractor" shall mean and include any person contracting with or employed directly by the owner or agent to do work upon, to render services for, or to furnish materials for, an improvement, but does not include a labourer.
 - b) "Council" shall mean and include the Council of the City of Humboldt.
 - c) "Employee" shall mean one who works for an employer for wages or salary and is provided with benefits such as Workers' Compensation, Unemployment Insurance and Canada Pension Plan.
 - d) "License Inspector" shall mean the Inspector of Licenses for the City of Humboldt and shall include the Assistant Inspector or Inspector of Licenses, if any, and anyone acting as such during his or her absence from duty for any cause.
 - e) "Person" shall include a Corporation, a partnership as well as men and women.
 - f) "Police" or "Police Officer" shall mean any member of the Royal Canadian Mounted Police or any Police Officer in the employ of the City.
 - g) "Resident" shall mean any person having an established place of residence in the City and who resided in the City for at least six (6) months prior to the date of application for license.
 - h) "Subcontractor" shall mean one who contracts to another contractor other than the ultimate consumer.
 - i) "City" or "Municipality" shall mean the City of Humboldt.
 - j) "City Commissioner", "Clerk" and "Treasurer" shall mean respectively the person occupying the position(s) of City Commissioner, City Clerk and City Treasurer of the City of Humboldt.

k) "Trades" shall mean any person who contracts out his or her services for gain to the ultimate consumer.

4. <u>License Inspector</u>

There shall be an officer appointed by the Council to be called a License Inspector of the City of Humboldt who shall hold office during the pleasure of Council.

5. <u>License Inspector Duties</u>

The following shall be the duties of the License Inspector under this Bylaw:

- a) To attend all meetings of Council or Committee's of Council whenever requested to do so or when he or she may find it necessary to do so on business connected with the duties of his or her office.
- b) To prepare a classified alphabetical list or lists, as the case may be, of all parties liable to take out a license and to use all diligence to have the same correct and to submit the same monthly or as often as required for examination and use by the City Commissioner.
- c) To keep a register containing the names of all persons applying for licenses, the names of all persons to whom licenses have been granted or refused, together within the latter case, the grounds for refusal, together within the latter case, the grounds for refusal and also the names of all persons to whom licenses have been transferred.
- d) To advise the City Commissioner or City Clerk on all matters incident to his office.
- e) To report when requested to Council or any standing Committee of Council.
- f) To make an inspection of all premises in connection with which a license is sought and to make any inquiry with reference to matters relating to the granting of licenses requisite to securing a due observance of the law.
- g) To visit as often as is necessary all houses and premises the owners or occupants of which are licensees under this Bylaw. To ascertain from time to time whether the premises licenses continue to remain in such a state as the Bylaw requires and if the house or other premises are well kept and orderly.
- h) To prosecute all persons guilty of offenses against this Bylaw and to be vigilant and active in the discharge of his duty.

6. License Required

No person shall carry on any of the several trades, occupations, callings or businesses hereinafter specified unless and until he or she has procured a license to do so pursuant to this Bylaw. Every person so licenses shall be subject to the provisions of this Bylaw.

7. License Fees

- a) The fee payable in respect of any license required under this Bylaw shall be the amount set out in Schedule "A" to this Bylaw.
- b) Schedule "A" of this Bylaw may be amended or substituted from time to time by bylaw of Council and shall subsequently form part of this Bylaw.

8. <u>Fees Payable</u>

All license fees required to be paid under the provisions of this Bylaw shall be paid to the City Commissioner or License Inspector at his or her office in the City Hall.

9. <u>Application for Licenses</u>

All applications for license, except as hereinafter provided, may be made verbally unless the License Inspector or City Commissioner directs the same to be in writing, in which case the application shall be addressed to the "City Commissioner of the City of Humboldt" and shall contain the following information:

- a) Name, address and occupation of the applicant.
- b) The nature of the license applied for.
- c) The place where the license is to be exercised or where the proposed calling is to be carried on.
- d) The period for which the license is required.
- e) Where a bond is required, the name of the bondsman or sureties, or the name of the guarantee company prepared to issue the necessary bond of indemnity as the case may be.
- f) In case the applicant desires to open a theatre, exhibition show or other place of amusement, the nature and description thereof must be provided.

10. Granting of Licenses

- a) All licenses required under the provisions of this Bylaw shall be issued by the City Commissioner or his or her representative, except where the Council reserves, to itself, the right to decide whether a license shall be issued or not.
- b) Where the City Commissioner or his or her representative refuses to issue a license, he or she shall forthwith submit the application for the license together with a report thereon to the Council and advise the applicant of the date on which the Council will consider the application.
- c) Every license granted under this Bylaw shall be made out in duplicate, and one copy shall be delivered to the Licensee, who shall produce the same whenever it may be demanded by any Police Officer in the employee of the City or other person duly authorized to demand the production.

11. Duration of Licenses

Every license granted under the provisions of this Bylaw, unless specifically mentioned to do for a shorter period and unless the same shall sooner become forfeited, will be for the year current at the time of issue thereof, and shall expire on the 31st day of December next succeeding the date of issue.

12. Reduction in License Fees

Unless otherwise provided for, the amount to be charged for all licenses issued shall be the yearly license fee. Any license issued on or after the first day of September, in respect to any business commenced after that date, shall pay one-half of the yearly license fee.

13. Single Occasion License Fee

A single occasion license fee shall be charged to a business for one occasion or contract.

14. Transfer of Licenses

a) Subject to this or any other Bylaw, a license granted pursuant to the provisions of this Bylaw unless otherwise provided for, may be transferred from one person to another or from one premises to another, on the payment of one-fourth of the annual amount payable for such license, but in no case shall the transfer fee be less than Ten (\$10.00) Dollars.

The provisions of this section shall not apply to licenses issued under the provisions of this bylaw to:

- 1. Taxis
- 2. Transient Traders
- 3. Any trade or business not specifically provided for (Unclassified) where there is a variation from the intent of the original license.
- b) No license may be transferred unless the person applying for such transfer has made application in every respect, as that required from an applicant for a license under the provisions of this Bylaw. No license shall be transferred until the owner thereof has endorsed on the back of the license authorizing the transfer of the said license.
- c) Any person who shall purchase the interest of the person licensed in any business, calling, article or thing, in respect of which a license has been issued under the provisions of this Bylaw and shall carry on or continue the said business, calling or keeping and using such article or thing without having first procured a license or having transferred the original license, shall be deemed guilty of an infraction of this Bylaw, and shall be subject to penalties thereof.

15. Display of License

a) Every licensee granted a license to carry on a business who occupies premises in connection therewith shall keep the license posted in a conspicuous place on the licensed premises.

b) All persons licensed under the provisions of this Bylaw where there are no licensed premises shall, on demand on the License Inspector or other person duly authorized in that behalf, produce the license to such officials.

16. Display of License Plates

Wherever in the Bylaw a licensee has received license plate in connection with the granting of a license, the said plate shall be displayed at all times as may be directed by the License Inspector.

17. Officials to Have Access to Licensed Premises

The City shall at all reasonable times have the right by its officials or employees, after being properly identified, to enter upon any premises licensed under the provisions of this Bylaw for the purpose of inspection or for the purpose of ascertaining if the provisions of this Bylaw are being complied with. Any person hindering, preventing or refusing such free access after any such person has demanded admission and has established his authority, shall be guilty of breach of this Bylaw.

18. Revocation of License

The Council may be resolution suspend or revoke any license granted or applied for under the provisions of this Bylaw. No rebates shall be allowed on any license fee paid unless authorized by the Council of the City.

19. Provincial Licenses

- a) No licenses shall be issued to any person required by law to obtain a Provincial License until the applicant has first produced the proper provincial license, and no license without such production shall be valid.
- b) The City License issued in such case shall state the fact that the Licensee has produced the proper Provincial License.
- c) Where a Provincial License requires endorsement by the City, such endorsement after payment of the prescribed fee shall obviate the issuance of a separate license.

20. Partnerships

In all cases of partnership firms, and such other exceptions as may be expressly set forth in this Bylaw, incorporate companies, troupes of actors, exhibitors, or other like combinations or association, no more than one license shall be required to be taken out for any one place or premises; but in the case of shows, a license shall be required for such separate shows or exhibitions when held under a separate canvas or tent.

21. Business on Streets or Lanes

Unless otherwise specifically provided for in this Bylaw, no person to whom a license is granted under the provisions of this Bylaw, shall conduct the business so licensed on any street or lane, except by special permission of Council.

22. <u>Licenses Required</u>

- a) Unless occupying a property taxed at the commercial rate or charged a license fee in lieu thereof, no person shall carry on in the City of Humboldt, any of the several trades, occupations, callings or businesses hereinafter specifically set forth, without first obtaining a license or transfer of license authorizing such person to carry on the respective trade, occupation, calling or business in the City, and paying to the City Commissioner or the License Inspector the respective fee or fees prescribed by Schedule "A" to this Bylaw for such license or transfer of license:
- 1. <u>Accountants and Bookkeepers</u> Any person engaged in the recording, classifying, summarizing, keeping and accounting of financial transactions and books for gain.
- 2. <u>Ambulance</u> Subject to the Public Health Act, any person operating an ambulance for hire within the City or partly outside the City's limits.
- 3. <u>Artist</u> Any person engaged in any of the fine arts (painting, drawing, sculpturing) and exhibits, or sells his/her works for gain.
- 4. <u>Author</u> Any person engaged in the writing of books, poems, stories, etc. and sells his/her compositions or books for gain.
- 5. <u>Auctioneer</u> Subject to the Auctioneer's Act, any auctioneer or other person selling or offering for sale goods, wares and merchandise or effects by public auction.
- 6. <u>Barber</u> Subject to the Public Health Act, every person carrying on business of a barber or tonsorial artist.
- 7. <u>Beauty Shops</u> Subject to the Public Health Act, every person carrying on business of manicurist, hairdresser, beautician, or other arts relating thereto.

The following regulation shall apply to both barber shops and beauty shops:

- a) No license shall be issued to any barber shop or beauty shop in any premises unless plumbing fixtures are provided, satisfactory to the plumbing inspector's inspection and connected where connection is possible with the public sewer and water mains, or not as the said plumbing inspector shall decide and provided that all water reuse is disposed in a manner satisfactory to the said plumbing inspector.
- 8. <u>Billiard Halls</u> Every person who owns or keeps directly or indirectly, or has in his or her possession or on his or her premises for hire or profit, any billiard, pool, snooker or other like table, whether such table is used or not.

The following regulations shall apply to billiard halls:

a) No game shall be played for money or anything of value in any premises in which billiard, pool, snooker or other like tables are kept, provided, however, nothing in this section shall prohibit the holding of tournaments under the rules of any local, Provincial, Dominion or like organization and the giving of trophies or prizes at such tournament.

- 9. <u>Book Binder</u> Any person operating a service which binds pages of books, magazines, pamphlets or other printed materials for gain.
- 10. <u>Building Movers</u> Every person who carries on the business of moving buildings from one place to another within the City, from any place within the City to any place outside the City, or from any place outside the City to any place within the City.
- 11. <u>Chiropractors and Drugless Practitioners</u> Every person who engages in business or chiropodists, chiropractor, manipulative healer or drugless practitioner.
- 12. <u>Circuses, Menageries and Shows</u> Every proprietor or manager of a travelling wax work, menagerie, circus show, theatre caravan or any other show.
- 13. <u>Common Carriers</u> Every person carrying on the business of common carrier for gain.
- 14. <u>Contractors</u> Any person contracting with or employed directly by the owner or agent to do work upon, to render services for or to furnish materials for, an improvement, but does not include a labourer.
- 15. <u>Craft Show or Exposition</u> A group of three or more people engaged in the business of producing, preparing, exhibiting or selling arts and crafts for gain.
- 16. <u>Dealers in Hides and Furs</u> Every person who carries on the business of dealing in hides and/or furs in City.
- 17. Direct Sellers Every direct seller as defined in the Direct Sellers Act.
- 18. <u>Dray</u> Every person keeping a dray, truck, cart wagon, or other vehicle whether motor or otherwise, each of which shall be included in the term and mean dray for hire and used in the transportation of goods, wares, merchandise or other articles from place to place within the City for gain.
- 19. <u>Dressmakers, Seamstresses and Milliners</u> Any person engaged in the business of preparing, mending, fixing or producing dresses, hats or any other garments for gain.
- 20. <u>Electrolysis</u> Subject to the Public Health Act, every person carrying on the business of the removal of hair by electrolysis.
- 21. <u>Electronic Appliance Research and Development</u> Any person engaged in the business of researching and developing new and/or improved electronic appliances or equipment for gain.
- 22. <u>Entertainers</u> Every person holding a public dance or entertainment where an admission fee is charged.

- 23. <u>Fuel Dealer</u> Every person who sells or offers for sale, coal, wood or coal and wood.
 - a) Provided that the provisions of this section shall not apply to farmers welling wood taken from their own farm.
- 24. a) <u>Garden Tilling</u> Every person engaged in plowing or cultivating gardens for gain.
 - b) <u>Snowplowing</u> Every person engaged in plowing snow for gain.
- 25. <u>Greenhouse</u> Every person carrying on the trade or business of a greenhouse operator selling flowers, plants, bulbs, bedding plants, nursery stock or other items of a like nature.
- 26. <u>Insurance Agents</u> Subject to the Insurance Premiums Tax Act, any person engaged in the preparing, selling or reselling insurance policies for gain.
- 27. <u>Janitorial Services</u> Any person engaged in providing or contracting janitorial or cleaning services to private homes, businesses, industries or governmental offices of institutions for gain, including the sale of janitorial and cleaning supplies.
- 28. <u>Landscaping Services</u> Any person engaged in the business of providing landscaping and exterior design services for gain.
- 29. <u>Mechanical Amusement Devices</u> Every person who keeps for hire or profit any instrument or mechanical device for playing recorded music, pinball machines, or other instrument machines or contrivances, no matter of what means of operation used for entertainment or amusement.

The following regulations shall apply to mechanical amusement devices:

- a) For the purpose of this Bylaw, a mechanical amusement device shall be deemed to be a pinball machine, video game machines or other game or contrivance of like nature.
- b) No mechanical amusement device shall be played for money or anything of value in any premises provided; however, nothing in this section shall prohibit the holding of tournaments under the rules of any legal, provincial, Dominion or other like organization and the giving of trophies or prizes at such tournament.
- 30. <u>Merry Go Round, Ferris Wheels, Etc.</u> Any person operating a merry-go-round, ferris wheel, or other amusement rides for gain.
- 31. <u>Music Teachers</u> Any person who teaches or instructs others in the use of musical instruments for gain.
- 32. <u>Music Association or School</u> Two or more teachers forming a legal entity who instruct others in the use of musical instruments for gain.

- 33. <u>Musical Instrument Repair</u> Any person who produces, repairs, mends or tunes musical instruments for gain.
- 34. <u>Pawn Brokers</u> Every person who carries on the business of pawn broker in the City.
- 35. <u>Pet Grooming Services</u> Any person engaged in a business of providing grooming, shearing, or cleaning services for domestic pets.
- 36. <u>Photographers</u> Every person who carries on the business of a photographer in the City, whether going from house to house or some place in City, but in all cases operating without an established studio.
- 37. <u>Private Clubs</u> Every person who operates a private club and is in the possession of a liquor license as issued under the Liquor Act.
- 38. <u>Real Estate Agent</u> Every person carrying on the business of real estate broker or agent who shall sell or negotiate the sale of any real estate, not his own property, and receive a commission or other remuneration.

39. Repairment and Appliance Repairmen

- a) Every person carrying on the business of repairing automobiles and/or other motor vehicles.
- b) Every person conducting general repairs to household furniture, including repairing or servicing of television sets or electrical appliances.
- 40. <u>Satellite Receiver Distributors</u> Every person distributing satellite receivers and ancillary equipment for gain.
- 41. <u>Scrap Metal Dealers</u> Every person who buys scrap metal or articles to be converted to scrap metal; from any person or collector for the purpose of resale to a third person, wholesaler, jobber or manufacturer within or outside the City.
- 42. <u>Sign Writers</u> Every person carrying on the business of sign writing for gain.
- 43. <u>Smallwares Peddlers</u> Any person engaged in selling wares under \$50.00 per person and has a direct sellers license as required in the Direct Sellers Act.
- 44. <u>Sporting Promoters or Entertainers</u> Every person carrying on the business of promoting sporting events or any entertainment event for gain.
- 45. <u>Stock and Financial Investment Agents</u> Subject to the Investment Contracts Act, any person who prepares stock portfolios for sale, advises clients with respect to stock and financial investments and arranges the sale of such portfolios or stocks and financial investments for gain.
- 46. <u>Taxis</u> Every person who owns or keeps for hire or profit a taxicab or taxicabs. For the purpose of this Bylaw, "Taxicab" shall mean and include every automobile used for the conveyance of passengers and shall include U-Drive automobiles.

- 47. <u>Taxidermist</u> Every person carrying on the business of preparing, stuffing and mounting the skins of animals.
- 48. <u>Theatres</u> Every person who owns or keeps for hire or profit any indoor or outdoor theatre, music or concert hall, Drive-in theatre, other building or other place used for theatrical dramatic, musical or other like amusement except local amateur performances.
- 49. <u>Trades and/or Subcontractors</u> Any person who contracts out his or her services for gain to either a contractor or the ultimate consumer in any one of the following described trades or fields of work:
 - a) <u>Carpenter</u> Any person who provides carpentry or wood working services for hire.
 - b) <u>Drywaller</u> Any person who provides plastering or drywalling services for hire.
 - c) <u>Electrician</u> Subject to the Electrical Inspection and Licensing Act, any person who provides wiring and electrical engineering services for hire.
 - d) <u>Mason</u> Any person who provides brick laying, stone work or other masonry services for hire.
 - e) <u>Painter</u> Any person who provides interior or exterior painting and finishing services for hire.
 - f) <u>Plumber</u> Subject to the Plumbing Contractors Licensing Act, any person who provides plumbing and drainage, engineering, installation, repair and maintenance services for hire.
- 50. <u>Transient Traders</u> Any person engaged in the selling of fish, fruit, produce, or general merchandise on a vacant lot, small parking lot, common area, trade show or exposition, or door to door.
- 51. <u>Tutors</u> Any person who teaches or instructs others in academic or scholastic courses for gain.
- 52. <u>Tutor Association or School</u> -Two or more tutors forming a legal entity who instruct other in academic or scholastic courses for gain.
- 53. <u>Unclassified</u> Every person carrying on a trade or business for gain, if in regard to licensing of the same no provision is anywhere made in this Bylaw, and who is not occupying a property taxed at the commercial rate.
- 54. <u>Vacuum Cleaner</u> Any person engaged in the selling of vacuum cleaners, floor scrubbers, floor polishers, door to door or in a vacant lot or common area.

- 55. <u>Vending Equipment Maintenance</u> Any person who is engaged in a business of servicing, repairing or providing mechanical or electronic maintenance for vending machines or equipment for gain.
- 56. <u>Vending Machines</u> Every person who keeps for hire or profit any mechanical vending machine.

23. Penalties

- a) A person who is guilty of a violation of any of the provisions of Section 6, 7, 14 and 22 of this Bylaw is liable to a fine of not less than \$250.00.
- b) A person who is guilty of a violation of any provision of this Bylaw for which no other penalty is herein provided, is liable to the penalties as provided in the General Penalty Bylaw of the City of Humboldt.

24. Repeal of Former Bylaws

Bylaws No. 26/95, No. 13/96, and No. 08/2000 of the City of Humboldt are hereby repealed.

25. This Bylaw shall come into full force and take effect immediately upon the final passing thereof.
