

Secondary Suite Incentive Program and Application Form

DESCRIPTION:

This program assists in the development of new secondary suites and the upgrading of existing secondary suites. Secondary suites offer an affordable rental option and can provide a revenue stream to enable homebuyers to enter the housing market.

ELIGIBILITY:

- Applicants must own existing property or be in the process of purchasing or contracting a newly constructed home that includes plans to develop a secondary suite.
- Applicants must house eligible tenants that have an annual gross household income below the applicable income threshold as set out by Saskatchewan Housing Corporation.
- Applicants must keep rents affordable based on the Saskatchewan Housing Corporation rent schedule for the term of the loan.
- The secondary suite must be a private, self-contained residential unit that meets all national, provincial and municipal bylaws, codes and standards.
- Funding subject to proof of Saskatchewan Housing Corporation ("SHC") approval of application.

GRANT DETAILS:

- The Secondary Suite Incentive is funded by the City of Humboldt in partnership with the SHC's program. SHC will provide a forgivable loan for 50% of the total construction/renovation costs to a maximum of \$30,000 per suite. The City will provide a homeowner a maximum grant of \$1500 based on 5% of the approved amount supplied by the SHC.
- If the grant recipient(s) defaults under the program in any way for a minimum 5 years, a pro-rata repayment of the grant is required
- The applicant must pay the property taxes in full (100%) each year (property taxes become effective the date of possession).
- The applicant must comply with all of the terms and conditions of the Program.
- A total number of units per year will be funded under this program on a first come first served basis.
- The total amount budgeted annually for this program by the City will be \$7500.
